Dear Sir/Madam:

All of our products are categorized as cosmetic products and as such are regulated by EC Regulation Nº 1223/2009 (and its successive modifications) concerning cosmetic products, and comply rigorously with the aforementioned legislation.

As Cosmetics, they are exempt from application of the Regulation EC 1272/2008 regarding classification, labelling and packaging of substance and mixtures and **the issue of safety data sheets is not required.**

Likewise, REACH regulation article 2, 6b also specifies that finished cosmetic products are exempt in everything related to chapter IV of said regulation, which dictates the necessity for safety data sheets.

Whether the products are affected by other laws, as is the case of aerosols, or by the annexes of the aforementioned legislation on cosmetic products, all risk phrases or conditions of use are compulsorily indicated on each container and / or label.

Likewise, and in compliance with the current legislation on cosmetic products, the labelling of the product also includes the complete qualitative composition, in accordance with the international nomenclature of cosmetic ingredients (INCI).

For this reason, we always recommend you consider the information present on the label because this is where the main product warnings and use are stated. However, below, we enclose a safety data sheet for the product's end user where mention is made of other warnings and considerations so that they can be taken into account for safer use of our product.

2. WARNINGS AND USER RECOMMENDATIONS

4. SAFETY INFORMATION

Storage:

- Store in a cool place.
- Do not expose to direct sunlight or other sources of heat.

Stability and possible reactions:

Measures for accidental spillage:

- Collect as much of the spilt product as possible with absorbent paper or rags. Eliminate the rest with plenty of water.
